To carry out the governing board's financial, equipment, building and infrastructure related advisory responsibility to ensure the institution's mission and purpose fulfilled by.

- 1. Gaining an understanding of how the institution is financially supported / capitalize
- 2. Assessing risks, Internal and external, that may have a financial impact on the institution.
- 3. Monitoring the institution's financial efficiency. Provide financial, equipment, building & other infrastructural guidance to the board of trustees
- 4. Assessing how to protect the institution's resources.
- 5. Overseeing the budgeting process to ensure that they are based on reasonable assumption, aligned with institutional goals and that they are properly mentioned.

- 2. Assist management in executing the strategic goals of the organization by:
- 3. Establishing guardrails for management regarding their financial decision making authority
